1. Expenditure under S137 Local Government Act 1972

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2024-25 was £10.81 per elector.

In 2024-25, the Council made payments totalling £2,431.69 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Llanidloes Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Annual Governance Statement

I am unable to conclude whether or not the Annual Governance Statement is consistent with the Council's internal controls and governance arrangements for the year:

 Assertion 7: The Council has not provided sufficient evidence to demonstrate that it consistently followed its internal controls when making payments. The Council did not provide sufficient evidence for 11 out of 20 payments tested.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Precept

The Local Government Finance Act 1992 requires the Council to set its precept as its calculated budget requirement. This means that the precept should be stated as a gross sum of money to be received by the Council.

The Council's minutes only record that the "2024/25 Budget and precept recommendation from Finance Panel was approved."

In order to ensure transparency, the Council should state the total amount of the precept that is to be raised.

Staff salaries

I have been unable to fully reconcile staff salary payments to contracts of employment. Our calculations indicate a potential small underpayment of salary. However, we have been unable to confirm this

We recommend that the |Council reviews its salary calculations to ensure staff salaries are paid in accordance with contracts.

Training Plan

The Local Government and Elections (Wales) Act 2021, requires the Council to create and publish a plan for councillor and staff training. The Welsh Government provides statutory guidance on this, which states that the plan must be approved by the full council and include details on the type of training, participant numbers, timeframe, and cost.

The training plan provided for audit does not contain the basic information required above.

We recommend that the Council reviews its Training Plan in line with the Welsh Government guidance.

Information required for audit

Each year we send the Council an audit notice that sets out the information we need to complete the audit. During the course of the audit, we may also issue further requests for information and evidence. Failure to provide this information may lead to a qualified audit opinion and potentially an increased audit fee.

We requested copies of rental agreements to support rental income received. The Council only supplied six out of eight agreements requested.

We recommend that the Council reviews the annual audit notice to ensure that all required information is provided on a timely basis.

There are no further matters I wish to draw to the Council's attention.
