Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £ NIL under section 137. These payments are included within 'Other payments' in the Accounting Statement.

### Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis for Qualification

#### Annual Governance Statement

In my opinion, the Annual Governance Statement is inconsistent with the Boards's governance arrangements for the year

- Assertion 4 – exercise of electors' rights. The Board approved the annual return after the commencement date for the exercise of electors' rights. The Board should approve the annual return prior to the commencement of the inspection period.
