At 6.30 pm, Councillors received a presentation from Mr Scott Bennett on behalf of Extinction Rebellion Llanidloes. XR was founding in 2016 to encourage the UK Government to take action on the issue of Climate change. The presentation will be e mailed to the Clerk who will send out to Councillors. 11 members of the Public were in attendance. The group wished for a Symbolic declaration by the Town Council expressing their concern and would like to see a Community led consultation on a Zero Carbon Llanidloes. Cllr G Morgan asked Mr Bennett how we as ordinary citizens can contribute? Discussion took place over buying local, supporting local farmers, cutting out meat a couple of times a week, reducing plastic usage, planting trees, public transport usage etc. Cllr Breeze asked if Council are going to be accused of being hypocritical as they burn wood pellets and use a diesel van? Mr Bennett said that no one should be labelled hypocrites as everyone is learning, starting with children. A Petition was handed in. Cllr Crisp thanked Mr Bennett for his presentation.

446/21 COUNCILLORS QUESTIONS

DOG FOULING - Clerk mentioned that dog fouling has become very bad in the centre of Town and had printed off more posters for Councillors if they wanted to display them

RATS –Cllr Crisp explained that residents of Brook Street were complaining. It was agreed that Clerk will set up a meeting with Mr Dave Morris, the Housing Officer to discuss further

REGISTRATION OFFICE Clerk had today received a letter from Suzanne Morgan, Superintendent Registrar to inform her that due to PCC Budget, the Llanidloes Registration Office will be closing. Councillors agreed to ask her to meet with them to explain their dissatisfaction with the decision that looks to have been taken without consultation.

XR LLANIDLOES Cllr Mc Arthur declared an interest and left the room. The Majority of Councillors (one abstention) agreed to sign up to the memorandum to declare a Climate and Biodiversity emergency.

LLANI IN BLOOM Cllr Crisp explained that she has received a quotation for self watering troughs to put at the 4 entrances to Town for a cost of £655 and a quote from Mid Wales Welding (not self watering) at £70 each. It was agreed to discuss further at the next Council meeting

GLASS AND PAPER BANKS Cllr Bennett asked if the glass and paper banks will be relocated. It was agreed to ask Mr Ashley Collins to come and meet Council to explain where the recycling will be going

CHRISTMAS TREE BASE Cllr Bennett asked Cllr Davies what is happening to the Concrete base which is currently outside the Town Hall. Cllr Davies stated that he has not had a chance to remove it but hopes to remove it next week.

100 YEAR OLD CITIZEN Cllr Bennett stated that Mrs Dorothy Hughes has recently had her 100th Birthday. Councillors agreed that a Birthday card should be sent to Mrs Hughes.

AGM, ELECTION OF MAYOR AND DEPUTY MAYOR 10th May was confirmed for the AGM and Mayor Making and 12th May for Mayoral Sunday. Forms for nomination of Mayor and Deputy were circulated and should be returned to the Clerk for 15th April for further discussion.
