- 461/05 TO RECEIVE LETTER FROM LLANIDLOES QUAKER MEETING AND TO DISCUSS REMEMBRANCE SUNDAY Cllrs A. Morgan, G. Morgan and T. Davies declared an interest and left the meeting. The letter from Llanidloes Quaker meeting was received, as well as the letter from RBL Llanidloes Women's section informing Council that their national organization advised that as this is a civic responsibility, they can no longer take responsibility for the organisation of any Remembrance Parade, Church Service or Assembly at the War Memorials. Cllr Bennett was sorry that Councillors had left the meeting as he would have liked them to stay and listen to the conversation. He made a proposal that the white poppy wreath is laid by the Deputy Mayor at the same time the red poppy wreath is laid by the Mayor and that any white poppy wreath will be laid during the official service which Town Council will take over the running of. This was seconded by Cllr Jamie Jones and Cllr John Hughes and unanimously agreed. It was agreed that Clerk will inform the Quaker meeting of this decision. Cllr Jamie Jones will contact Zach Evans to play the last post. 2 stewards will be asked to stop traffic at each end of Great Oak Street. Mr Tony Crisp, Mayors Consort will be asked to recite the Kohima and an ex service person will be asked to give the Exhortation. Cllr Jamie Jones thanked the Mayor for organising the VJ Day service which was very tastefully done and well organised. Cllr Margot Jones also thanked the Mayor and Town Clerk for organising the event.
- 461/06 TO DISCUSS THE TRANSFORMING TOWNS FUND AS INFORMATION RECEIVED FROM PCC Clerk briefly explained the information she had received from PCC and had sent out to Councillors last week.
