462/04 TO RECEIVE THE FOLLOWING CORRESPONDENCE

- 462/05 TO RECEIVE LETTER FROM RBL LLANIDLOES WOMEN'S SECTION AND TO DISCUSS REMEMBRANCE SUNDAY FURTHER TO LEGISLATION/GUIDANCE RECEVIED FROM WELSH GOVERNMENT SINCE LOCKDOWN MEASURES DUE TO BE INTRODUCED FROM FRIDAY 23RD OCTOBER The letter was received. Clerk explained that she has been in touch with RBL regarding wreaths to be laid, however Government guidance is very confusing as we are in total lockdown. The Welsh Minister has made a statement allowing socially distanced Remembrance Services to go ahead with a maximum of 30 people in attendance. It was agreed that the Mayor & Deputy will lay wreaths on behalf of the residents of Llanidloes at 11.00 am. Town Clerk will also attend the Cenotaph at this time along with the Vicar. Mr Tony Crisp will read the Kohima and Mr John Breeze will read the Exhortation. All other organisations will be informed that they can lay a wreath at a time convenient to them. The last post will be played at 11.00 am. Councillors will attend with social distancing adhered to at all times. The Police have been informed of the actions of the Town Council.
- 462/06 UPDATE ON THE TRANSFORMING TOWNS FUND AS INFORMATION RECEIVED FROM PCC Clerk informed Council that she has received applications from 2 businesses in Town and has passed the information on to Mr Gareth Evans at PCC and would expect to hear more once he current lockdown is eased.
- 462/07 UPDATE ON MEETING HELD WITH ZERO CARBON LLANIDLOES (Cllr Crisp and Bennett) AND TO ELECT 2 MEMBERS OF TOWN COUNCIL ON TO THE ZCL GROUP IF AGREED BY TOWN COUNCIL Cllr Hughes agreed to become a Council representative on this group. Cllr McArthur expressed concerns over the Constitution provided by the ZCL group as section 5 states direct action could be taken. It was agreed to write back to the group stating that Council is supportive of their basic intent and what they are trying to achieve but are not willing to join this group unless section 5 is altered.
- 462/08 TO ELECT 2 MEMBERS OF THE TOWN COUNCIL ON TO THE ONE VOICE WALES AREA COMMITTEE There were no nominations for members to join this committee
- 462/09 TO DISCUSS ITEMS RECEIVED FROM THE ESTATE OF LADY HOOSON AND WHERE TO ARCHIVE (Cllr G. Morgan) Cllr Morgan suggested that Ms Eva Bredsdorff (an ex employee of PCC Museum) should be approached with a view to cataloguing the artefacts received from Lady Hoosons estate. Council agreed that Cllr Morgan should approach Ms Bredsdorff with a view to this taking place. Clerk explained that she had received some very interesting artefacts from a local resident in the Town and they should be looked at, catalogued property and displayed in the Town if possible. A letter from Lady Hooson's family was received requesting Town Council to formally take custody of the Llanidloes Drama Festival Silver Challenge Cup on the condition

- i) They would never dispose of it
- ii) They retain it in safe custody as part of the Town's archives
- iii) In the hope that one day the festival might be revived
 - Clerk will write back to the family thanking them for the Cup and the archive material received.
- 462/10 TO RECEIVE NOTIFICATION OF CLAIM OUTCOME FOR LOSS OF INCOME TO LLANIDLOES TOWN COUNCIL FOR QUARTER ONE 2020-21 Clerk explained that the amount of £2,184.84 had been applied for them the Welsh Government due to the COVID pandemic and received. She will apply for monies for the second quarter once informed the time is right.
- 462/11 TO DISCUSS HALF YEARLY ACCOUNTS AND BUDGET SPREADSHEET AS SENT BY E MAIL Cllr Breeze informed Council that the Budget as spreadsheet sent out to all Councillors was on track for the first half of the year. There were no questions from Councillors on this subject.
- 462/12 UPDATE FROM TEAMS MEETING HELD WITH MEMBERS OF PCC Cllr Crisp explained that she and the Clerk attended the virtual meeting and were surprised and concerned at the amount of funding which had been allocated to both Machynlleth School (£43M) and to Builth School (65M) but there had been no monies allocated to Llanidloes School. Cllr Margot Jones as Chair of Governors declared an interest but was asked to speak. She expressed concern as there are lots of areas of the School requiring attention but there were no monies coming forward for the purpose. I was agreed that Cty Cllr Phyl Davies as Portfolio holder along with an officer would be invited to meet with Council to answer some concerns.
- 462/13 UPDATE ON MEETING WITH MRS NINA DAVIES PCC AT MAESYDRE PLAYGOUND (Cllr G Morgan) Cllr Morgan informed the meeting that Mrs Davies had been reluctant to meet but he was hopeful that after the current lockdown period a meeting will be set up
